- **Qualitative Analysis:** Interviews will be analyzed to identify key themes and insights about teenagers' perspectives on freelancing.

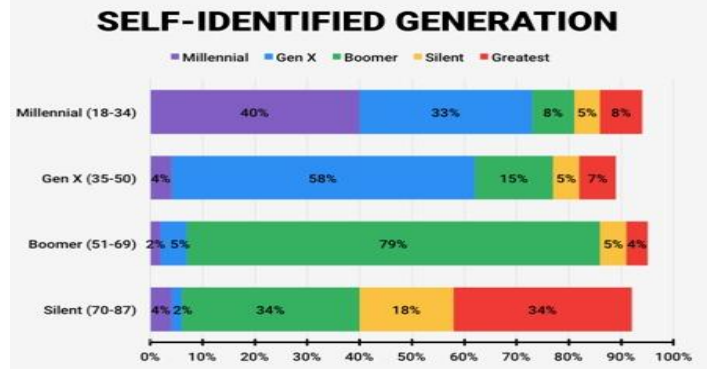
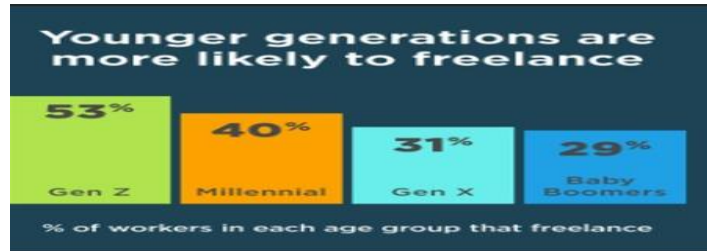
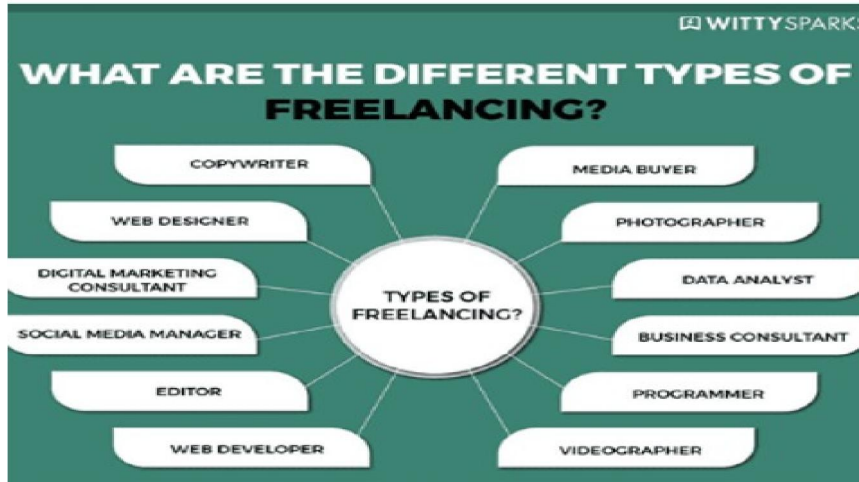

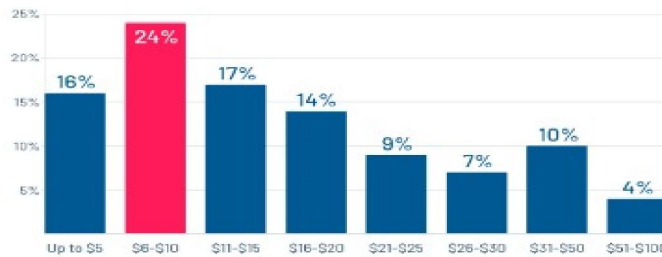
